#### 2. DUNS NUMBER



A 'D-U-N-S Number' is a unique 9-digit number used around the world to identify and access information on businesses. In order to apply for federal funds, this number is required. Go to <a href="https://dnb.com">dnb.com</a> to get your number. (It's free! but takes time to apply...)

The Commercial And Government
Entity Code is another unique identifier
assigned to various organizations
through SAM (System for Award
Management) by DLA (Defense
Logistics Agency). This is also free but
can take up to 10 business days!

## DO YOU HAVE AN EIN NUMBER? ARE YOU A NON-PROFIT OR FOR-PROFIT?

#### 5. EIN NUMBER



An EIN Number is a unique 9 digit number. An Employer Identification Number (EIN) is also known as a Federal Tax Identification Number and is used to identify a business entity. Visit irs.gov to get your number.

Familiarize yourself with all of the requirements of the funding opportunities you are considering. One of the most common questions is what entity your organization is. Keep in mind that numerous grants will require proof of tax-exempt status, if applicable. Don't be discouraged if you run a for-profit business, there are opportunities out there that cater to you as well as creative ways to partner with non-profits.

## HAVE ALL YOUR DUCKS IN A ROW

- 1. It's always a great idea to have as much information compiled in a folder (whether it is google drive, dropbox, or any other way you keep your information) so that when you go through the grant application it will be easier for you copy and paste the information into the application.
- 2. Curate your application to what the grantors want! Go through previous winners and the foundation's background to make sure you are inline with their values. This will make you a stronger candidate.
- 3. Have all your financials squared away? It is always good to have your taxes and audits up to date in general and some grantors would want to see your last 3 years of financial statements and or other tax information (be well prepared).
- 4. Even if you don't get the grant the first time around, it is custom that feedback will be available on where you can improve. The likelihood of you receiving the grant in the next cycle increases exponentially because they would have been already familiar with your organization.
